2. Scrutinizer's Responsibility

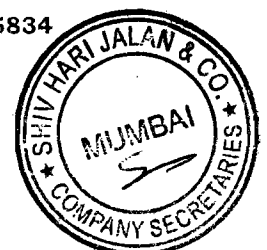


3. Cut-off Date
